<p><b><i>Introduction</i></b></p>	<p>Brooklands Capital Strategies BD, LP (“BCS” or the “Firm”) is a broker-dealer registered with the Securities and Exchange Commission (“SEC”), a member of the Financial Industry Regulatory Authority (“FINRA”), and a member of the Securities Investor Protection Corporation (“SIPC”). Brokerage and investment advisory services and fees differ, and it is important that you understand the services BCS provides and costs associated with those services. This Form CRS is designed to provide you an easy to read overview of our services, conflicts with providing those services, and fees and costs associated with those services. This Form CRS also provides you “Conversation Starters” or considerations you might want to discuss with your financial professional. <p><b><i>“What investment services and advice can you provide me?”</i></b></p>	<p>BCS acts as a placement agent for alternative asset managers direct private investment opportunities. We enter into engagements with companies to assist them in obtaining funding from investors (primarily institutional investors and, in some cases, retail investors). In this line of business our clients are the companies who are seeking funding. We identify a select group of these private investment opportunities with whom to engage and then target investors we think may be interested in these opportunities. In doing so, we conduct thorough due diligence on our clients (the investment opportunities) and then assist them in their fundraising efforts, which includes introducing investors (e.g. you). We generally will only conduct outreach to investors with a specific opportunity that we think will be of interest. We do not actively manage or recommend offerings on an ongoing basis nor are we generally engaged by investors to source investment opportunities.</p> <p><b><u>Conversation Starters:</u></b></p> <ul style="list-style-type: none"> <li>• <i>Given my financial situation, should I choose a brokerage service? <p><b><i>What fees will I pay?</i></b></p>	<p>As payment for selling private placements BCS will typically receive a fee in the amount of a percentage of the amount invested. This fee is paid to BCS directly by the company that issues the securities. This payment does not come out of the amount that you invest and will not otherwise affect the amount that you have invested. Any fees that you will pay relating to the investment are outlined in the investment opportunity’s offering documents. Please reference the private placement offering documents for detailed information on these fees.</p>

	<p>We will earn fees whether you make or lose money your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.</p> <p><b>Conversation Starters:</b></p> <ul style="list-style-type: none"> <li>• <i>Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?</i></li> </ul>
<p><b>What are your legal obligations to me when providing recommendations? How else does your firm make money and what conflicts of interest do you have?</b></p>	<p><b>When we provide you with a recommendation</b> we must act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they affect the recommendations we provide to you. Here is an example to help you understand what this means:</p> <p>There may be similar private placement offerings that you could invest in, but we only recommend those where we have an engagement with the company issuing the securities. We address this conflict by making sure that the issuers we recommend to investors are suitable in general and then only conduct outreach to investors for whom we believe the investment may be of interest and suitable. This can only be accomplished when we fully understand the investment products we sell. We will perform extensive due diligence to determine that we understand the nature of the products, as well as the potential risks and rewards associated with each product.</p> <p><b>Conversation Starters:</b></p> <ul style="list-style-type: none"> <li>• <i>How might your conflicts of interest affect me, and how will you address them?</i></li> </ul>
<p><b>How do your financial professionals make money?</b></p>	<p>In an effort to eliminate potential conflicts of interests, our financial professionals do not earn transaction-based commissions. Rather, they earn a salary and discretionary bonus based overall performance of the Firm as well as their individual performance at the Firm.</p>
